For us it is important that the personal data held about you is accurate and current. Please keep me informed if your personal data changes during your relationship with me for the use of my services.

When you read "we", "us" or "our" in this privacy policy, we are referring to the relevant company of Chapelford Pet Sitting Services.

By providing me with your data, you warrant to me that you are over 13 years of age.

What Data Do We Collect About You

Personal data means any information capable of identifying an individual. It does not include anonymised data.

We may process certain types of personal data about you as follows:

Identity Data may include your first name, maiden name, last name, username, marital status, title, date of birth and gender.

Contact Data may include your home address, billing address, delivery address, email address and telephone numbers.

Financial Data may include invoicing information (including company name and invoice address) which you provide to us when you choose to make a payment.

Transaction Data may include details about payments between us.

Marketing and Communications Data may include your preferences in receiving marketing communications from us and your communication preferences.

We also collect, use and share Aggregated Data such as statistical or demographic data for any purpose. Aggregated Data may be derived from your personal data but is not considered personal data in law as this data does not directly or indirectly reveal your identity. For example, we may aggregate your Usage Data to calculate the percentage of users accessing a specific website feature. However, if we combine or connect Aggregated Data with your personal data so that it can directly or indirectly identify you, we treat the combined data as personal data which will be used in accordance with this privacy notice.

We do not collect any Special Categories of Personal Data about you (this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health and genetic and biometric data). Nor do we collect any information about criminal convictions and offences.

Where we are required to collect personal data by law, or under the terms of the contract between us and you do not provide us with that data when requested, we may not be able to perform the contract (for example to carry out our services to you). If you don't provide us with the requested data, we may have to cancel a service you have requested but if we do, we will notify you at the time.

How We Collect Your Personal Data

We collect data about you through a variety of different methods including:

Direct interactions: You may provide data to me to record during our consultation on a consultation form by communicating with us by post, phone, email, SMS, Whatsapp. Facebook, Messenger or otherwise, including when you request any of our services as listed below:

Dog Walking

Pet sitting in your own home

House Sitting

Administering medication to your pet including preventative medication, claw trimming and other help needed for the wellbeing of your pet.

Automated technologies or interactions: As you use our site, we may automatically collect Technical Data about your equipment, browsing actions and usage patterns. We collect this data by using cookies, server logs and similar technologies. We may also receive Technical Data about you if you visit other websites that use our cookies. Google Analytics are an example of analytic providers used.

Email Links: If you email us directly, or via an email mailto hyperlink, the email is transmitted to us via the Simple Mail Transfer Protocol (SMTP). Depending on your email provider, the email contents may or may not be encrypted from the point at which it leaves your computer until it reaches your email provider or in some cases, until it reaches us. We have no control over this, but most popular email providers like Gmail do provide end-to-end encryption.

Third-party links

Our website may include links to third-party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third-party websites and are not responsible for their privacy statements. When you leave our website, we encourage you to read the privacy notice of every website you visit.

How We Use Your Personal Data

We will only use your personal data when legally permitted. The most common uses of your personal data are:

Where we need to perform the contract between us.

Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.

Legitimate reasons may include sharing information with a veterinary professional within your own veterinary practice, group of practices or any other veterinary practice used for the treatment and care of your pet whilst in my care. This also includes veterinary referral clinics, centres or hospitals etc. Also the need to share information as requested with your pet/home insurance company if needed, as well as any other person noted on our consultation form or whom you instruct to me to act as an emergency contact if you cannot be reached and urgent care is needed for your pet(s) and/or home. Where it is necessary to liaise with any authorised body in relation to our services being used or needed and this may

include for example council licensing authorities, RSPCA, emergency services like the police or fire services as well as any of your home security/alarm companies if needed whilst using my services.

Where we need to comply with a legal or regulatory obligation.

Generally, we do not rely on consent as a legal ground for processing your personal data, other than in relation to sending marketing communications to you via email or text message. You have the right to withdraw consent to marketing at any time by emailing us at chapelfordpetsittingservices@gmail.com

How Is Your Information Used?

Collecting this data helps us understand what you are looking for from our business, enabling us to deliver excellent services, and in particular for the following reasons:

to contact you in response to a specific enquiry or request of services offered

to collect payments and send invoices and statements if requested

to supply the services

to notify you of changes to our legal terms or compliance requirements etc

to contact our customers relating to past, present and future services

to inform you of any changes to our pet sitting/dog walking/house sitting/animal care services due to holidays, illness or adverse weather conditions etc

Chapelford Pet Sitting Services publishes feedback received from clients on the website, which may contain personally identifiable information. A photo of your pet posing may be used with your testimonial. The client feedback sheet is available for new clients to read as this helps provide reassurance and builds trust when a new client may be anxious about using a pet sitting service. Your pets daily update photos may appear on the Facebook page for Chapelford Pet Sitting Services but owner details are never published on social media.

We do obtain permission from all clients prior to publishing the testimonial and posting pet pictures to social media. However, if you wish to request the removal of your testimonial, please let me know.

Change Of Purpose

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose. If we need to use your personal data for a purpose unrelated to the purpose for which we collected the data, we will notify you and we will explain the legal ground of processing.

We may process your personal data without your knowledge or consent where this is required or permitted by law.

Data Security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit access to your personal data to those volunteers/workers who have a business need to know such data. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

Data Retention

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements.
